Chad Double is a seasoned veteran with 22 years of service in the Farmington Hills Police Department, located in a diverse metropolitan Detroit community of over 80,000 residents in Oakland County, Michigan. The Farmington Hills Police Department is renowned as one of Michigan's premier full-service law enforcement agencies, recognized for numerous state, national, and professional group awards for exceptional police service delivery.

In 2008, Chad was assigned to the Investigative Division. As a Detective, he specialized in cases involving domestic violence, child abuse, sexual assault, and computer crimes. Currently, Chad is an active member of the Farmington Hills Coordinating Community Response Team, a multi-disciplinary group focused on identifying high-risk domestic violence cases and creating a coordinated community response, including prevention and education initiatives. In 2018, Chad was promoted to Patrol Sergeant, and in 2019, he was reassigned to the Investigative Division as a Sergeant. In 2023, Chad achieved the rank of Patrol Lieutenant.

Chad has extensive experience as a law enforcement instructor who has taught at various institutions since 2004. He has been involved with the Oakland Community College Advanced Police Academy since 2019, instructing in areas such as Report Writing and Documentation, Basic Detective School, and Police Reserve Academy. Additionally, he has taught at the Oakland Community College Basic Police Academy since 2004, covering subjects like Michigan Motor Vehicle Law, Types of Patrol, and Domestic Violence Scenario Training. Their experience also includes teaching at the Washtenaw Community College Police Academy since 2016, focusing on Report Writing, Domestic Violence Response, and Child Abuse. He has been associated with the Michigan Commission of Law Enforcement Standards (MCOLES) since 2018, instructing on Law Enforcement Response to Domestic Violence and Stalking/PPO/Bond Violations.

Furthermore, he has been a consultant and instructor at 2x Services LLC since 2017, specializing in Report Writing and Michigan Marijuana Law. Their recent experience includes teaching at the Schoolcraft College – Wayne County Regional Police Academy from 2022 to 2024, where he covered Juvenile Offenders and Domestic Violence Response Procedures.
