Holding a Bachelor of Arts degree in Criminal Justice Management, his career spans multiple agencies, where he has worked in uniformed patrol, specialized enforcement units, and leadership roles as a patrol corporal and sergeant. His investigative experience includes assignments as a general detective, major narcotics investigator (Cal-MMET), and major crimes investigator, serving with both the Galt Police Department (CA) and the Spokane County Sheriff's Office (WA). Additionally, Lieutenant Elliott has been an active IADLEST certified national instructor since 2019.

Beginning as a Sergeant in 2015, Lieutenant Elliott has served a vital role in law enforcement training and leadership, leading the Spokane Regional Air Support Unit and managing the Sheriff's Field Training & Evaluation Program during a critical period of hiring and staffing growth. Since 2009, he has instructed at the FTO Academy through the Washington State Criminal Justice Training Commission (WSCJTC) and has served as both a PTO and FTO since 2006.
